economic interest owners or obligations to pay or remain in business.

License Includes:

1. Exclusive rights to all tangible patents, trademarks, logos, copyrights, videos, ^{J.J.} ~~models or technical data explicitly created for or provided to REAL FLIGHT LLC~~ ^{RADICAL}
by licensor. Part or all of this may be sublicensed or sold (and thus no longer under license) if an agreement is reached between ~~REAL FLIGHT LLC~~ ^{RADICAL J.J.}
and a buyer to sell and transfer asset(s) or sell the company. Formal IP and/or patent transfer is hereby pledged to occur (or occur on demand if not completed) by the customary legal documents and conveyances.

2. Rights to ~~REAL PAPER FLIGHT~~ (which presently includes a YouTube channel and website) and all Licensor's (James Zongker's) paper aircraft designs and documented ideas for the purpose of developing marketable toys & products. (This grants right to use any of this intellectual property, but not ownership over the physical items & documents themselves) This access includes proprietary trade secret information not to be disclosed if not made public by either James and/or decision of voting ~~REAL FLIGHT LLC~~ ^{RADICAL J.J.} members. This intellectual property may be patented by ~~REAL FLIGHT LLC~~ ^{RADICAL J.J.} if warranted. This ~~FLIGHT~~ ^{RADICAL J.J.} is put up for sale unless the licensor or his heirs elect to release all or part of it in a sale in whatever form it exists in, as a part of the deal. Access rights are not exclusive; James may use or disclose this intellectual property, with an obligation to exercise reasonable due care ~~not~~ to protect portions that have a reasonable likelihood of making money.

3. Access to the licensor's (James') expertise. This is intangible and cannot be sold, ~~loaned~~ or transferred, and is not exclusive. James may use or disclose his expertise, with an obligation to exercise reasonable care to protect portions of it with a reasonable likelihood of making money.
