ASSIGNMENT

And we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said invention or resulting from said application and from any and all divisions, continuations, and reissues thereof, to **John DaSilveira**, his successors, assigns, designees or other legal representatives, as assignee of **DSS**'s entire interest, and hereby covenant that **DSS** has the full right to convey the entire interest herein assigned, and that **DSS** has not executed and will not execute any agreement in conflict herewith.

And **DSS** further hereby covenants and agrees that **DSS** will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such Letters Patent as may be granted therefore, to **John DaSilveira**, his successors, assigns, designees, or other legal representatives and that if **John DaSilveira**, his successors, assigns, designees or other legal representatives shall desire to file any divisional or continuation applications or to secure a reexamination or reissue of such Letters Patent, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of **John DaSilveira**, his successors, designees or other legal representatives.

And **DSS** does further covenant and agree that it will, at any time upon request, communicate to **John DaSilveira**, his successors, assigns, designees or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to it, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, designee, its successors, or other legal representatives.

And **DSS** hereby agrees that it will upon request execute any instrument which **John DaSilveira**, or whomsoever that company may nominate, desires to carry this Assignment in effect, and perfect the title transferred hereby, or to prosecute any of the above-mentioned applications or any foreign application on this invention.
