**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (this "Release"), dated as of September 21, 2020 is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent and Collateral Agent (the "Collateral Agent") under the Credit Agreement referred to below in favor of **BILLY GOAT INDUSTRIES, INC.**, a Missouri corporation, (the "Granting Pledgor") (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement or the Security Agreement, as applicable).

WHEREAS, in connection with that certain Senior Secured Debtor-in-Possession Revolving and Term Credit Agreement, dated as of July 22, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Briggs & Stratton Corporation, a Wisconsin corporation (the "Lead Borrower"), each of the other Borrowers, the Lenders, the Issuing Banks, and the Collateral Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrower;

WHEREAS, the Granting Pledgor and the other U.S. Loan Parties entered into that certain U.S. Senior Secured Debtor-in-Possession Collateral Agreement dated as of July 22, 2020 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, in connection with the Credit Agreement and Security Agreement, the Granting Pledgor executed and delivered certain agreements described on Schedule A attached hereto (collectively, the "Patent Security Agreement"), the Granting Pledgor granted security interests in the Patent Collateral (as such term is defined in the Patent Security Agreement), including those listed on Schedule A attached hereto (the "Collateral"); and

WHEREAS, the Patent Security Agreement was recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Schedule A hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby **RELEASES**, terminates, cancels and discharges, without representation, recourse or warranty whatsoever, in its entirety its security interest in and to the Collateral and terminates the Patent Security Agreement. The Collateral Agent hereby reassigns, re-transfers and re-conveys to the Granting Pledgor any and all of its rights, title and interest in and to the Collateral, together with (1) all proceeds and products of such Collateral and (2) all causes of action arising prior to or after the date hereof for infringement of such Collateral or unfair competition regarding the same, and any and all other rights, title and interest in and to such Collateral and related rights that the Collateral Agent may have.


The Collateral Agent agrees, at Borrower's expense, to cooperate with Borrower, to take all further actions and to provide Borrower with the information and additional authorization, in each case, as reasonably required or desirable to effect the purpose of this Release. The Collateral Agent hereby authorizes this Release to be filed and recorded with the United States Patent and Trademark Office and any other offices as may be necessary to carry out the intention of this Release. The Collateral Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
