Introduction

- (B) The inventors of the Patents are or have been employees of the Assignor.
- (C) The Patents are registered in the name of the Assignee.
- (D) It has always been the understanding that all right title and interest in and to the Patents and the Inventions vest in the Assignee and the parties hereby wish to confirm this position.

Operative Clauses

1. Definitions

In this Assignment the following words shall have the following meanings:

"Effective Date"	26 January 1998
"Future Inventions"	rights to all future inventions a) devised by employees of the Assignor and/or b) to which the Assignor becomes entitled to by operation of law or contractual agreement including without limitation the right to apply for and own patents in respect of such inventions anywhere in the World.
"Inventions"	The inventions claimed in the Patents
"Patents"	any and all of the patents and patent applications referred to in the attached Schedule 1 including any continuations, continuations in part, extensions, reissues, divisional applications, present and future national and/or regional phase applications derived from international applications and including any patents, supplementary protection certificates and similar rights

	that are based on or derive priority from the foregoing and/or have common priority therewith.

2. For the avoidance of doubt in consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor HEREBY ASSIGNS to the Assignee absolutely and the Assignee hereby accepts an assignment of such right title and interest as the Assignor may have in and to the Inventions and the Patents with effect from the Effective Date.
3. The assignment at clause 2 above shall include, without limitation, the assignment and transfer of:
 - 3.1 all patents that may be granted pursuant to any applications listed in Schedule 1 as well as all patents that may derive priority from or have equivalent claims to or be based upon the Patents in any country in the World (and including continuations, continuations in part, extensions, reissues, divisional applications, present and future national phase applications derived from international applications and including any patents, supplementary protection certificates and similar rights that are based on or derive priority from the foregoing and/or have common priority therewith and the right to priority); and
 - 3.2 all rights of action, powers and benefits arising from ownership of the Patents in particular the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to on or after the date of this Assignment.
4. The Assignor agrees and confirms that all Future Inventions shall belong to the Assignee. The Assignor hereby assigns to the Assignee all Future Inventions to the fullest extent permitted by law. Insofar as they do not so vest automatically by operation of law or under this Assignment, the Assignor holds legal title in such Future Inventions on trust for the Assignee. The Assignor agrees to do all acts necessary to confirm that absolute title in Future Inventions vests in the Assignee.
5. The Assignor HEREBY COVENANTS with the Assignee that it will at the expense of the Assignee execute, sign and do, all such instruments, applications, documents acts and things as may reasonably be required by the Assignee to enable the Assignee to enjoy the full benefit of the property and rights hereby assigned.
6. This Assignment shall be governed by and construed in accordance with English Law and the English Courts shall have non-exclusive jurisdiction in respect of it.
