## ASSIGNMENT

THIS ASSIGNMENT is made on the 11th day of the month of February of the year two thousand and 2016, between CNH INDUSTRIAL BELGIUM NV, a corporation duly organized and existing under and by virtue of the laws of Belgium and having a registered address at Leon Claeyssstraat, 3A, B-8210 Zedelgem, Belgium (hereinafter referred to as "the Assignor") of the one part and CNH INDUSTRIAL AMERICA LLC, a corporation duly organized and existing under and by virtue of the laws of the State of Delaware, United States of America, and having a registered address at 500 Diller Avenue, P.O. Box 1895, New Holland, Pennsylvania, 17557-0903, USA (hereinafter referred to as "the Assignee") of the other part.

### WHEREAS

(A) The Assignor is the beneficial joint owner of the entire right, title and interest, domestic and foreign, in the improvements in the following:

#### CONTROL METHOD AND APPARATUS FOR A ROTOR CAGE WITH ACTUATED CAGE VANES IN A HARVESTER

invented by Frank R.G. Duquesne, Jonathan E. Ricketts, Herbert M. Farley, Wayne T. Flickinger, Brecht Vanmullem, Arno Laenknecht, Dré Walterus Joachim Jongmans and Glenn Aesaert; set forth in the application for United States Patent having serial number 15/041679 (hereinafter referred to as "the US Application"), describing said improvements and any United States Patents granted therefor; of any and all Applications for Patent and Patents granted therefor in any and all other countries, including all divisions, reissues, continuations and extensions therefor (hereinafter referred to as "the Patent Rights"); and of the right of priority resulting from the filing of said US Application.

(B) The parties hereto have agreed that the Assignor's Patent Rights in said improvements should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

### NOW IT IS HEREBY AGREED that:

1. In consideration of the sum of one dollar now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged), the Assignor as beneficial joint owner hereby assigns its right, title and interest, resulting from the filing of said US Application, including its right of priority, any and all Applications for Patent (hereinafter referred to as "the Corresponding Applications") and any and all Patents granted pursuant to the Corresponding Applications (hereinafter referred to as "the Corresponding Patents"), any and all divisions thereof and its rights, powers, liberties and immunities arising or accrued therefrom including its right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of the specifications accompanying the Corresponding Applications, to the Assignee free from all license charges or other encumbrances to the intent that the filing of the Corresponding Applications and a grant of the Corresponding Patents thereon shall be in the name of and shall vest in the Assignee to hold unto the Assignee absolutely.

2. The Assignee hereby accepts such assignment.

3. At the request and cost of the Assignee, the Assignor shall assist the prosecution of said Corresponding Applications to grant and will assist the defense of any proceedings by way of intervention or in opposition to the Corresponding Applications or grant of Corresponding Patents and will execute all such deeds and documents and do all such acts as may be necessary or desirable formally to register this Assignment at regional and national patent offices and to render this Assignment effective under the laws of relevant regional and national jurisdictions and to procure the grant of the Corresponding Patents pursuant to the Corresponding Applications.

4. The Assignee shall by virtue of this Assignment be entitled to the filing of the Corresponding Applications and the grant of the Corresponding Patents in its own name.
