## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement, is entered into June 12, 2020 (the "IP Security Agreement") by and between Thomas Stachura, an individual residing at 8525 Davies Rd NW, Edmonton, AB T6E 4N3, Canada (the "Buyer") and Xiao Ming Mai, an individual residing at 5 Lafayette Way, Cranbury, NJ 08512 (the "Seller").

### RECITALS

This IP Security Agreement is a supplement to the PATENT PURCHASE AND ASSIGNMENT AGREEMENT, by and between the Buyer and Seller (the "PPA Agreement").

If there is a conflict between the definitions, terms or provisions of this IP Security Agreement and the PPA Agreement, the definitions, terms or provisions of the PPA Agreement shall control.

This IP Security Agreement is executed for the purpose of memorializing the security interest outside of the PPA Agreement. Seller shall have the right, at Seller's discretion, to record this IP Security Agreement in the United States Patent and Trademark Office (the "USPTO") and, if applicable, any foreign patent offices, where at least one IP Collateral exists, to perfect Seller's security interest in the IP Collateral.



### GRANT OF SECURITY INTEREST

In exchange for execution of the PPA Agreement, Buyer hereby grants to the Seller a security interest in, and lien on, all of the intellectual property assets set forth in **Exhibit 1** hereto, and any intellectual property assets directly or indirectly claiming priority thereto, wherever located, and whether now owned or hereafter acquired, including all rights to sue for infringement of such intellectual property assets, and all proceeds of any of the foregoing in any form and wherever located, and whether now owned or hereafter acquired (collectively the "IP Collateral").

### REPRESENTATIONS, WARRANTIES, COVENANTS AND MISCELLANEOUS

All other terms, conditions, agreements, obligations, representations, warranties, covenants, definitions, exhibits and miscellaneous terms, conditions, agreements and obligations set forth in the PPA Agreement are restated and incorporated herein by reference as the basis for the security interest granted herein.
