## ASSIGNMENT

THIS ASSIGNMENT is made the 31 day of October 2018 BETWEEN:

BRIND AB, a Swedish Company of Atlasgatan 8, 80286 Gävle, Sweden (hereinafter "the Company" which expression shall be deemed to include its successors and assigns) of the first part,

JERKER PERSSON, a Swedish citizen of Södra Åbyggebyv 27, 80598 Gävle, Sweden (hereinafter "the Designer" which expression shall where the context admits be deemed to include their executors heirs administrators and assigns) of the second part and

Q-LINEA AB, a Swedish Company of Dag Hammarskjöds väg 52A, 75237 Uppsala, Sweden (hereinafter "the Assignee" which expression shall be deemed to include its successors and assigns) of the third part

### WHEREAS

1. The Company was commissioned by the Assignee to design features of an apparatus for medical tests.
2. The Designer has contributed to the making of a Design for an "Apparatus for Medical Tests" (hereinafter "the Design").
3. At the time of making the Design the Designer was a co-owner of the Company and made the Design in the course of his duties as a co-owner of the Company.
4. The Design is the subject of Hague Union International Design Registration No. DM/100917 filed on 20 April 2018 which was filed in the name of the Assignee (hereinafter "the Application").
5. The Designer, the Company and the Assignee are desirous that all property right, title and interest in and to the Design and in the Application including the right to claim priority therefrom and any registered designs and other rights issuing thereon shall be vested in the Assignee, and that, for consideration hereinafter set forth, the Designer and Company shall assign and transfer unto the Assignee all their remaining rights titles and interest in and to the Design and the Application.

NOW THEREFORE THIS DEED WITNESSETH THAT


FOR and in consideration of the sum of Ten Swedish Krona (10 SEK), the receipt and sufficiency of which are hereby acknowledged, the Designer and Company HEREBY assign transfer and sell unto

the Assignee all their remaining rights title and interest in and to the Design and the Application including the right to claim priority from the Application in any application for a registered design or other intellectual property rights in respect of the Design, whether national, regional or international, in or for any country in the world, including any right to make applications for and to be granted registered designs and other intellectual property and like rights, whether national, regional or international, in or for any country in the world, and the right to sue for damages and other remedies in respect of any infringement of such rights TO HOLD the same unto the Assignee absolutely

FURTHER the Designer and Company hereby covenant with the Assignee that they will not publish or disclose or assist or procure others so to do any particulars of the Design without the consent of the Assignee and that at the expense and promptly on the request of the Assignee they will sign execute and do all such documents or acts as may be required by the Assignee in order to enable the Assignee to procure and enjoy the full benefit of the Design and of all registered designs or other intellectual property rights in respect thereof in all countries of the world


