FIRST: That a meeting of the Board of Directors of Alios BioPharma, Inc. was held on August 28th, 2018 and resolutions were duly adopted setting forth the proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof.
