THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN PATENT RIGHTS (this "Release") is made as of October 1, 2020 ("Effective Date") by and between Innerworkings, Inc. (the "Grantor"), in favor of BANK OF AMERICA, N.A., a national banking association, as administrative agent for certain secured parties (in such capacity, the "Agent").

The lien and security interest evidenced by that certain Patent Security Agreement ("Security Agreement"), dated as of July 16, 2019, made by and between Grantor and Agent, which was duly recorded on July 19, 2019, at Reel 049800, Frame 0024 in the United States Patent and Trademark Office, and any other right, title or interest granted to the Agent in the patents set forth on Schedule 1 attached hereto is hereby terminated, cancelled, discharged and released, without representation or warranty, and the Agent hereby re-assigns, grants and conveys to the Grantor any right, title or interest it may have in the Patent Collateral (as defined in the Security Agreement), including any of the patents set forth on Schedule 1.


The Agent agrees to take all further actions, and provide to the Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance reasonably requested by the Grantor, at the applicable Grantor's sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York, without regarding to conflicts of law or choice of law principles.
