ASSIGNEE accepts the assignment;

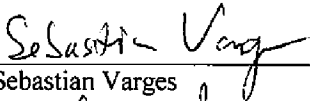

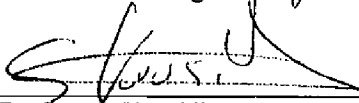

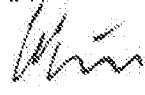
