RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS, dated as of October 8, 2020 (this "Release"), is made by U.S. BANK NATIONAL ASSOCIATION, as Collateral Trustee (the "Collateral Trustee"), in favor of OMNIMAX INTERNATIONAL, INC. WHEREAS, the Grantors have requested and the Collateral Trustee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Intellectual Property Collateral.

Collateral Trustee hereby authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Trustee's rights under the Intellectual Property Security Agreement with respect to the Intellectual Property Collateral granted thereunder, including, without limitation, the patents listed on Schedule A hereto.
