DECLARATION WITH REGARD TO MODIFICATION OF ARTICLES OF ASSOCIATION

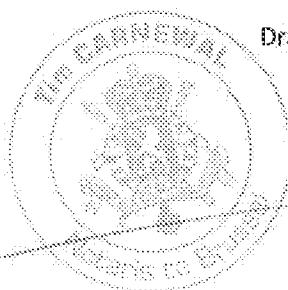
I, **Tim CARNEWAL**, notary public, member of the cooperative company with limited liability "Berquin Notaires", having its seat at 1000 Brussels, Avenue Lloyd George 11, registered with the company register of Brussels under number 0474.073.840, hereby declare that on 19 December 2019, the extraordinary general assembly of the Belgian private limited liability company **IVC BVBA**, having its registered office at Nijverheidslaan 29, 8580 Avelgem, registered with the company register with number 0866.682.231 (hereafter "the Company"), has taken inter alia the following decisions:

- The early application of the Code on Companies and Associations (opt-in) and adoption of the legal form of a limited liability company (besloten vennootschap) ("**IVC BV**"), in application of article 39, §1 second alinea of the Law of 23 March 2019 on the introduction of the Code on Companies and Associations and various dispositions.

- Adoption of a new text of articles of association in which the representation toward third parties is from as follows:

*"Nonetheless the general competence of representation of the executive body as a board, the company is represented toward third parties in justice as (i) by two directors, acting jointly, (ii) within the boundaries of the daily management by the persons charged with the daily management and (iii) by special proxy holders within the boundaries of their mandate. (article 14)".*

The aforementioned decisions do not interrupt the legal personality of the Company, nor does it imply a transfer of the registered office of the Company, it does not modify the company number, nor the VAT number of the Company, who will have as of today the name **IVC BV**.
