
NOW THE PARTIES AGREE follows:

The Assignor will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to the Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all utility applications, divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the Assignee, its successor, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.


