
WHEREAS, the aforesaid inventors are obliged by terms of employment or other agreement to assign all right, title and interest in the Applications to the Assignee;


AND, we hereby further agree for ourselves and our executors and administrators to execute upon request our other lawful documents and likewise to perform any other lawful acts
