## ASSIGNMENT

### PARTIES:

### AND

upon the Application in any country of the world, and references to the Application in this Assignment shall be deemed to include all such items of property, and all rights of action, powers and benefits arising from ownership of the Application, including without limitation the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to, on or after the date of this Assignment.

3. MSC agrees with Waters to execute all such documents and give all such assistance at the expense of Waters as Waters may require in order to enable Waters to enjoy the full benefit of the rights assigned in this Assignment.
4. MSC further hereby assigns to Waters any and all copyright in any drawings of or associated with the Inventions and the development thereof and any and all rights in any design relating to or associated with the Inventions and the development thereof.
