Preamble

Buyer has acquired Seller and intends to liquidate Seller. Before, all patents of seller will be transferred to Buyer. Subject of this Patent Assignment Agreement (in the following referred to as "Agreement") are all patents of Seller as listed in Annex 1 (in the following referred to as "Patents").

§ 1 Subject matter

1. Seller herewith assigns the Patents and any national and foreign counterparts or other patents or utility models or pending applications for the same claiming the priority of one or more of the Patents to Buyer.
2. The Patents remain the property of Seller until the purchase price has been paid in full. After the complete payment, Seller will agree to the recording of the assignment of the Patents in the register of the German Patent Office and/or the Patent Offices of the respective countries of the Patents and Seller promises to provide the required documentation and to sign all necessary forms and documents to effectuate the assignment.

§ 2 Transfer of documents, formulae, miscellaneous etc.

Seller promises to submit to Buyer all documentation, research documents, tabulations, experimental reports, irrespective of whether in written, electronic or in other form, as well as any machines, tools and prototypes, which relate to the subject matter of the inventions of the Patents.

§ 3 Purchase Price

1. The purchase price is . The purchase price is due on and payable in one instalment.
Payment shall be made by wire transfer into the following account:

2. Any transaction-related taxes that should be due in any jurisdiction shall be borne by Buyer.

§ 4 Warranties

1. Seller declares that legal defects in the Patents and technical defects in the invention are not known to him. In particular, Buyer is not aware of any challenge to the validity of the patents or their scope of protection. Seller has not granted any licenses to the patents to third parties. To the best of Seller's knowledge, the patents do not infringe any third party's rights. Seller warrants that all patent office fees for the current term of the patents have been duly paid by Seller.
2. A liability for freedom of defects, particularly dependency of the invention, is not undertaken. Unless expressly stated otherwise in this agreement, all rights of warranty or rescission by Buyer are excluded.
3. Buyer is aware of the technical features of the invention. The Seller is not liable for the technical utility and completeness of the technical documents under § 2 above.

§ 5 Confidentiality clause; No-Challenge

1. Seller will keep the know-how relating to the patented process confidential after the signature of the agreement.
2. Seller will not challenge the validity of the Patents and will not assist third parties in any such challenge.

§ 6 Costs


The costs and fees of this agreement as well as all costs for the assignment and recording of the Patents will be borne by Buyer. Buyer will also pay all fees and costs for the maintenance of the Patents after the execution of this agreement.

§ 7 Miscellaneous


1. All disputes arising out of or in connection with this agreement shall be subject to the jurisdiction of the courts in Hamburg, Germany.
2. This agreement shall be subject to German law with the exception of the rules of the UN Convention on Contracts for the International Sale of Goods (CISG).
3. This agreement was entered in in the written form. Any change or amendment shall require a written document signed by both parties. This shall also apply to a waiver of this written form requirement. No oral side agreements have been made.
4. Should any provision of this agreement be invalid or unenforceable, this shall not affect the enforceability of the remainder of the agreement. The parties will substitute any such invalid or unenforceable provision with an enforceable provision that is closest to the commercial effect of the provision that is invalid or unenforceable.
