**DEED OF ASSIGNMENT  
OF  
INTELLECTUAL PROPERTY RIGHTS**

---

THIS DEED OF ASSIGNMENT ("Assignment") is dated this 12<sup>th</sup> day of DECEMBER 2016 ("Effective Date")

#### BETWEEN

- (1) **NOM TECHNOLOGY LTD**, a limited liability company registered, organised and existing under the laws of England and Wales with its principal place of business located at 37<sup>th</sup> Floor, One Canada Square, Canary Wharf, London, E14 5AA, United Kingdom and registered under number 09515910 (the "**Assignor**"); and
- (2) **NUM TECHNOLOGY LTD**, a limited liability company registered, organised and existing under the laws of England and Wales with its principal place of business located at 29<sup>th</sup> Floor, One Canada Square, Canary Wharf, London, E14 5AA, United Kingdom and registered under number 10097965 (the "**Assignee**"),

together the **parties**, and each a **party**.

#### RECITALS

- (A) The Assignor is the owner of the Works IP.
- (B) The parties desire for the legal and beneficial ownership of all the Works IP to be transferred from the Assignor to the Assignee. Pursuant thereto, the parties desire to enter into this Assignment on the terms below.

#### IT IS AGREED:-

##### 1. Definitions

- 1.1. **IP**: means any patents (including the Patent), utility models, trade marks (including the Trade Mark), registered designs or any application for registration of the same or right to apply for the same (including, but not limited to, continuations, continuations in part, renewals, divisionals, extensions and/or re-issues), any copyrights or neighbouring or related rights, database rights, design rights, rights in trade, business or domain names, rights in trade dress, logos and get-up, rights in goodwill or to sue for passing off, unfair competition rights, rights in computer software, rights in inventions, publication rights, rights in confidential information, semi-conductor topography rights, trade secrets and know-how or any similar or equivalent rights in any part of the world, which subsists now or in the future;
- 1.2. **Patent**: means the patent application set out at **Schedule 1** to this Assignment;
- 1.3. **Trade Mark**: means any trade mark used by the Assignor in the course of business (registered or unregistered), to expressly include those trade marks set out at **Schedule 1** to this Assignment; and
- 1.4. **Works IP**: means the IP in any works and/or materials created and/or produced and/or acquired by the Assignor up to and including the Effective Date, including but not limited to models, prototypes, software, data, databases, formulae, specifications, inventions, concepts, processes, techniques, analyses, compilations, studies, reports, text, artwork,

graphic designs, three dimensional designs, moulds, photographs, names, logos, preparatory works and any other works or materials.

## **2. Assignment**

The Assignor hereby irrevocably conveys, sells, transfers and assigns unto the Assignee with full title guarantee ALL THAT the Assignor's full rights, title and interest in all countries of the world in:

- (a) the Works IP;
- (b) all rights relating or attaching to the Works IP including the absolute entitlement to any registrations granted pursuant to any applications to register any Works IP and any rights of renewals and/or maintenance for the full terms thereof;
- (c) the right to register and/or apply for registration of any eligible Works IP and obtain registered IP protection in the UK and all other countries of the world for the Works IP which shall include the right to claim priority from the Patent and any other patent applications; and
- (d) the right to bring legal proceedings for damages and other remedies in respect of any infringement of any Works IP which may have occurred prior to the Effective Date,

TO HOLD the same unto the Assignee absolutely.

## **3. Warranties**

3.1. The Assignor warrants that:

3.1.1. it is the legal and beneficial owner of all right, title and interest in the Works IP, and has all necessary rights, licences and permissions to enter into this Assignment on the terms herein;

3.1.2. it has not licensed, or purported to licence, any rights within the Works IP or assigned, or purported to assign, any of the Works IP (or any part therein) to any third party, and shall not in the future purport to do so; and

3.1.3. the Works IP are free from any security interest, option, mortgage, charge or lien.

3.2. The Assignor does not give any warranty, representation or undertaking:

3.2.1. as to the efficacy or usefulness of the Works IP;

3.2.2. that any Works IP shall proceed to grant; or

3.2.3. that any information communicated by the Assignor to the Assignee under or in connection with any Works IP shall produce products of satisfactory quality or be fit for the purpose for which the Assignee intended.

3.3. Each party acknowledges that, in entering into this Assignment, it has not relied on any warranty, representation or undertaking except those expressly set out in this Assignment

and each party waives any claim for breach of any representation (unless made fraudulently) which is not specifically contained in this Assignment as a warranty.

#### **4. Moral Rights**

The Assignor waives, and shall procure the waiver of, any moral rights arising under the Copyright, Designs and Patents Act 1988 in relation to any works in which Works IP subsist and, as far as is legally possible, any broadly equivalent rights the Assignor or others may have in any country and/or territory of the world.

#### **5. Further Assurances**

The Assignor shall at the request of the Assignee, do all acts and things (including, without limitation, executing all documents necessary and/or desirable and providing all necessary assistance) to give effect to the terms herein, including but not limited to (i) securing the vesting in the Assignee of all right, title and interest in the Works IP, (ii) providing all such assistance as the Assignee may require in the event that any person or entity bring a claim against the Assignee alleging that the reproduction, use or exploitation of any work in which Works IP subsist infringes the rights of any third party, and (iii) entering into novation(s) to give the Assignee and their heirs and/or successors in title the full benefit of clause 6.1.

#### **6. General**


- 6.1. The rights and obligations in this Assignment shall be fully assignable by the Assignee. The rights and obligations in this Assignment may only be assigned by the Assignor with the prior written consent of the Assignee and shall be subject to any conditions imposed thereon.
- 6.2. This Assignment constitutes the entire agreement and understanding between the parties with regard to its subject matter and supersedes all prior oral or written agreements, representations, understandings or arrangements between the parties relating to its subject matter. Any changes to this Assignment shall be made in writing and signed by the duly authorised representatives of each party.
- 6.3. This Assignment may be executed in any number of counterparts, each of which when executed shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.
- 6.4. No one other than a party to this Assignment, their successors and permitted assignees, shall have any right to enforce any of its terms. For the avoidance of doubt, nothing in this Assignment confers or is intended to confer any rights on any third party pursuant to the Contracts (Rights of Third Parties) Act 1999.
- 6.5. This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales and the parties hereby

irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to hear and determine any such dispute or claim.


