**RELEASE OF SECURITY INTEREST
IN PATENTS**

This **RELEASE OF SECURITY INTEREST IN PATENTS** (this “**Release**”), dated as of October 26, 2020, is made by CAPITAL ONE, NATIONAL ASSOCIATION, in its capacity as Administrative Agent for the Lenders and Secured Parties (the “**Administrative Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement and the Security Agreement).

WHEREAS, in connection with that certain Credit Agreement dated as of June 1, 2017, as amended and restated on October 1, 2018 and as further amended, supplemented or otherwise modified from time to time, collectively, the “**Credit Agreement**”), by and among GeoDigm Corporation, as Borrower, the other Loan Parties from time to time party thereto, the Lenders and L/C Issuers from time to time party thereto and Administrative Agent, the Lenders have severally agreed to make extensions of credit to the Borrower;

WHEREAS, in connection with the Credit Agreement and together with all general security agreements and patent security agreements entered into in connection therewith, and pursuant to that certain Patent Security Agreement, dated June 8, 2020, between National Dentex, LLC (the “**Grantor**”) and Administrative Agent (the “**Security Agreement**”), Grantor granted to the Administrative Agent a security interest in the Patent Collateral (defined below) owned by Grantor; and

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on June 8, 2020 at Reel/Frame 052869/0922.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Security Agreement; (ii) releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the following Collateral of the Grantor, whether granted pursuant to the Security Agreement or any other agreement or document delivered in connection with the Credit Agreement (collectively, the “**Patent Collateral**”):

(a) all of its Patents and all IP Licenses, providing for the grant by or to the Grantor, of any right under any Patent, including, without limitation, those referred to on Schedule I hereto;

(b) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(c) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof; and

(iii) reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the Patent Collateral to the Grantor.

The Administrative Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to


effect the release of the Administrative Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
