The Inventor hereby covenants and agrees to do all such things and to execute without further consideration such documents as may be reasonably required to file and prosecute applications for protection of the Invention in such countries as shall be determined by the Assignee, and at the expense of the Assignee to give all reasonable assistance in obtaining and enforcing any such protection.
