**TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS** (this "**Termination and Release**") is granted as of October 23, 2020 by **Ankura Trust Company, LLC**, as successor agent to **Patriarch Partners Agency Services, LLC** (the "**Agent**"), in favor of **RM Acquisition, LLC**, a Delaware limited liability company (the "**Pledgor**").

**WHEREAS**, pursuant to the Security Agreement dated as of December 6, 2007, (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), among the Pledgor, RM Canada Holdings, LLC, a Delaware limited liability company and the Agent, the Pledgor executed and delivered to the Agent that certain Patent Collateral Security Agreement dated as of September 1, 2011 (the "**Patent Security Agreement**"), granting the Agent a security interest in and lien on the Patents (as defined in the Patent Security Agreement);

**WHEREAS**, security interest in patents was recorded with the United States Patent and Trademark Office ("**USPTO**") on October 10, 2011, at Reel 027038, Frame 0107;

**WHEREAS**, the Pledgor has requested that the Agent terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Pledgor in, to and under all of the Patents, including the patents as fully described on the attached Schedule I as herein provided; and

**WHEREAS**, the Pledgor has requested that the Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Patents as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby states as follows:

1. **Release of Security Interest**. The Agent, without recourse, representation or warranty of any kind, hereby terminates the Patent Security Agreement and releases, terminates and discharges all liens and security interests in the Pledgor's right, title and interest in, to and under the Patents, all registrations and applications for registrations of the Patents, including the patents and applications set forth in Schedule I, together with all reissues, divisions, continuations, continuations-in-part, substitutes, renewals, and extensions thereof, and all right to sue and recover for infringement of the Patents.

2. **Recordation**. The Agent authorizes and requests that this Termination and Release be recorded at the USPTO by the Pledgor.

3. **Further Assurances**. Agent agrees to take all further actions, and provide to the Pledgor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case, at the Pledgor's expense, as the Pledgor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Termination and Release.

4. **Governing Law**. This Termination and Release and the rights and obligations of the parties under this Termination and Release shall be construed in accordance with and governed by the law of the State of New York.
