**AMENDMENT NUMBER FOUR TO GRANT OF SECURITY INTEREST IN  
PATENT RIGHTS**

This **AMENDMENT NUMBER FOUR TO GRANT OF SECURITY INTEREST IN PATENT RIGHTS**, dated as of September 24, 2020 (this "Amendment"), is delivered pursuant to that certain Grant of Security Interest in Patent Rights, dated as of February 11, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Patent Security Agreement"), among Grantors listed on the signature pages thereof and Grantors thereafter joined as parties thereto (collectively, jointly and severally, "Grantors" and each individually "Grantor"), and **BANK OF AMERICA, N.A.**, as collateral agent for the several banks and other financial institutions from time to time parties to the Credit Agreement (in such capacity, together with its successors and assigns in such capacity, "Collateral Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings set forth in the Patent Security Agreement, which by this reference is incorporated herein.

WHEREAS, Grantors and Collateral Agent are parties to that certain Grant of Security Interest in Patent Rights, dated as of February 11, 2014 and recorded with the United States Patent and Trademark Office on February 12, 2014 at Reel 032251, Frame 0277, as amended by that certain Amendment Number One to Grant of Security Interest in Patent Rights, dated as of February 2, 2017 and recorded with the United States Patent and Trademark Office on March 22, 2017 at Reel 041681, Frame 0826, as further amended by that certain Amendment Number Two to Grant of Security Interest in Patent Rights, dated as of May 17, 2018 and recorded with the United States Patent and Trademark Office on May 17, 2018 at Reel 046187, Frame 0922, and as further amended by that certain Amendment Number Three to Grant of Security Interest in Patent Rights, dated as of May 7, 2019 and recorded with the United States Patent and Trademark Office on June 19, 2019 at Reel 049522, Frame 0643; and

WHEREAS, Grantors and Collateral Agent wish to further amend the Patent Security Agreement by amending Schedule A to the Patent Security Agreement to add certain Patents to the Collateral, and Grantors and Collateral Agent have agreed to do so.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree to amend the Patent Security Agreement as follows:

1. Grantors and Collateral Agent hereby agree that Schedule A to the Patent Security Agreement is hereby amended by adding the Collateral listed on Exhibit A attached hereto (the "Additional Patent Collateral"), which such Additional Patent Collateral shall be and become part of the Collateral referred to in the Patent Security Agreement and Schedule A attached thereto and shall secure all Obligations.

2. Each Grantor hereby: (a) reaffirms all prior grants of security interests in favor of Collateral Agent in all of such Grantor's right, title, and interest in, to, and under the Collateral identified on Schedule A to the Patent Security Agreement prior to the effectiveness of this Amendment; (b) grants, assigns, and pledges to Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in all of such Grantor's right, title, and interest in, to, and

under the Additional Patent Collateral identified on Exhibit A attached hereto; (c) represents and warrants that the representations and warranties in the Patent Security Agreement, as amended by this Amendment, are true and correct in all material respects on and as of the date hereof, as though made on such date; and (d) agrees that the Patent Security Agreement as amended hereby is and shall remain in full force and effect.

3. THE VALIDITY OF THIS AMENDMENT, THE CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT HEREOF, AND THE RIGHTS OF THE PARTIES HERETO WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.


