THIS ASSIGNMENT is made BETWEEN :

- (1) **Lino Cosaro, Giulio Benedetti, Michelangelo Bulgarelli and Jvanohe Rizzi** (hereinafter called "the Inventors" which expression where the context so allows shall include their personal representatives and assigns);
- (2) **SEALED AIR S.r.l.** a company organized and existing under the laws of Italy and having its principal place of business at Via Trento 7, 20017 Passirana di Rho, Milan, Italy and formerly denominated Cryovac S.p.A. (hereinafter called "Sealed Air" which expression where the context so allows shall include its successors and assigns) ; and
- (3) **CRYOVAC, Inc.** a company organized and existing under the laws of the State of Delaware , and having its principal place of business at 100 Rogers Bridge Road, Duncan 29334, South Carolina, United States of America (hereinafter called "Cryovac US" which expression where the context so allows shall include its successors and assigns)

WHEREAS :

- (A) The Inventors claim to be the inventors of an invention ("the Invention") relating to ***"Packaging apparatus with evacuation assembly and packaging process"***, full particulars whereof have been communicated by them to Sealed Air which they are informed is the subject of one or more applications for patent protection as identified in the Schedule hereto and in respect of which they have (as they hereby acknowledge) approved a specification for patent protection in the European Patent Office submitted to them by Sealed Air;

- (B) The Invention was made by the Inventors in the course of their employment by Sealed Air in "The Packaging Technical Center" near Milan in Italy and (as the Inventors hereby admit) under the terms of the Inventors' contract of employment and the provisions of Article 64(4), first paragraph, of the Italian Patent Law (D.leg. February 10, 2003, no. 30), Sealed Air became immediately entitled (as against the Inventors) to all the right, title, and interest of the Inventors in and to the Invention together with the full right to apply for and obtain a patent or patents or other similar forms of protection or exclusive privileges in respect thereof in the European Patent Office, the United States of America ("the USA"), and all other countries of the World;
- (C) Sealed Air is an affiliated company of Cryovac US and expenditure for pure research activity incurred by Sealed Air in connection with "The Packaging Technical Center" aforesaid is funded by payments received from Cryovac US and (as Sealed Air hereby admits) by virtue of the arrangements subsisting between Cryovac US and Sealed Air at the date of the Invention, Cryovac US became immediately entitled (as against Sealed Air) to all the right, title, and interest of Sealed Air in and to the Invention together with the full right ("the Patent Rights") to apply for and obtain a patent or patents or similar forms of protection or exclusive privileges in respects thereof in the European Patent Office, the USA and all other countries of the World in the name of Cryovac US alone or as Cryovac US may from time to time otherwise elect or the relevant law may require; and
- (D) The Inventors have agreed at the request of Sealed Air and Cryovac US and Sealed Air has agreed at the request of Cryovac US to execute this Deed on the terms herein contained

NOW THIS DEED WITNESSETH as follows:

1. In pursuance of the said agreements and in consideration of the premises, the Inventors and Sealed Air HEREBY JOINTLY and SEVERALLY and to extent of their respective shares and interests therein ASSIGN and CONFIRM unto Cryovac US ALL THOSE their respective rights, titles, shares, and interest in and to the Invention and the patent applications (if any) identified in the Schedule hereto and all patents granted thereon or any parts thereof and any continuation, division, or reissue thereof in the European Patent Office, the USA and all other countries of the World AND the full and exclusive benefit thereof TOGETHER WITH all rights of action and powers accruing or belonging to the Inventors or Sealed Air AND the Patent Rights including the benefit of any priority date and the right to make applications whether under any national law or under the International Convention for the Protection of Industrial Property or under any other applicable convention or treaty TO HOLD the same unto Cryovac US absolutely.

2. The Inventors and Sealed Air HEREBY JOINTLY and SEVERALLY COVENANT and AGREE with Cryovac US as follows:
 - (i) That they will at any time hereafter (whether or not the Inventors remain in the employ of Sealed Air) and from time to time at the request and expense of Cryovac US promptly execute and sign all such instruments, applications, and documents and do all such acts and things as may be required by Cryovac US to enable Cryovac US to enjoy the full benefit of the rights hereby confirmed and assigned;

 - (ii) That they have not assigned or agreed to assign to any person, firm, or company other than Cryovac US or otherwise encumbered and will not hereafter assign or agree to assign to any person, firm, or company or otherwise encumber the Invention or the said patent applications (if any) or

the Patent Rights;

- (iii) That the Inventors will give to Sealed Air and to Cryovac US and Sealed Air will give to Cryovac US all such information in their possession or in their power relating to the Invention and the method of using or employing the same as Sealed Air or Cryovac US shall from time to time require; and
 - (iv) That they have not disclosed and will not hereafter disclose the Invention or any information whatsoever concerning the same to any person, firm, or company other than Sealed Air or Cryovac US as the case may be or their respective Patent Agents, unless to people or companies bounded by a written Confidentiality Agreement.
3. This document shall be governed by and construed in accordance with the Italian law.

IN WITNESS whereof the Inventors have signed and Sealed Air and Cryovac US in accordance with their respective constitutions have executed this Instrument as their Deed in the presence of the persons mentioned below the day and year first before written.
