## INTELLECTUAL PROPERTY ASSIGNMENT & CONFIRMATORY ASSIGNMENT

This Intellectual Property Assignment (this "Assignment") is made this 1<sup>st</sup> day of April, 2020, by and between Litecure LLC, a Delaware limited liability company, ("Company" or "Assignee") on the one hand, and BWT Property Inc., a Delaware corporation (also known as and/or a related entity with BWT Property, Inc., B&W Tek, Inc. and B&W TEK Inc.), Mr. Brian Pryor (residing in Newark, Delaware), and Mr. Sean Xiaolu Wang (residing in Wilmington, Delaware) (collectively known as "Assignors") on the other hand.

WHEREAS, Assignors desire to assign, and Company desires to accept from Assignors, certain intangibles identified on Exhibit A attached hereto and all related rights (the "Assigned Intangibles").

NOW, THEREFORE, for the aggregate consideration of one dollar (\$1.00), the receipt and sufficiency of which is hereby acknowledged, Assignors hereby irrevocably assign, convey, and transfer to Company any and all of Assignors' Intellectual Property Rights in the Assigned Intangibles. For purposes hereof, "Intellectual Property Rights" is defined as all U.S. and foreign intellectual property, intellectual property rights and industrial property rights (throughout the universe, in all media, now existing or created in the future, for all versions and elements, in all languages, and for the entire duration of such rights) arising under statutory or common law, contract, or otherwise, and whether or not registered or otherwise perfected, including without limitation, all (a) patents, reissues of and reexamined patents, and patent applications, whenever filed and wherever issued, including without limitation, continuations, continuations-in-part, substitutes, and divisions of such applications and all priority rights resulting from such applications; (b) divisions, continuations, renewals, reissues, revisions or equivalents or counterparts thereof and extensions of the foregoing (as and to the extent applicable) now existing, or later filed, issued, or acquired; and (c) causes of action, rights, and remedies arising under any of such rights that accrued prior to, on, or after the date of this Assignment, including the right to sue for past infringement damages and economic rights of authors and inventors.

Assignors reserve no rights in any Assigned Intangibles. Assignors hereby waive any and all paternity, integrity, moral and other similar rights that Assignors may have now, or in the future, in the works of authorship that are embodied in the Assigned Intangibles. The rights assigned under this Assignment include, without limitation, the right to claim priority based on the filing date of the Assigned Intangibles under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Conventions, and all other treaties of like purposes.

Assignors authorize the Register of Copyrights of the United States, the U.S. Patent and Trademark Office, and any Official of any country or countries foreign to the United States whose duty it is to receive or register patents or applications therefore, to record Company as the owner of the intellectual property embodied in the Assigned Intangibles and to issue all registrations for said Assigned Intangibles, to be in the name of Company, as assignee of the Assigned Intangibles, for the sole use of Company, its successors, legal representatives, and assigns, in accordance with the terms of this Assignment.

If Assignors have any rights in the Assigned Intangibles described in the definition of Intellectual Property Rights that cannot be assigned to Company in accordance with this Assignment, then Assignors grant to Company either (i) an exclusive (even as to Assignors), fully paid, royalty-free, perpetual, irrevocable, transferable, unlimited license with the right to sublicense and sue for infringement and other damages, throughout the universe, in all media, now existing or created in the future, for all versions and elements, and in all languages, to use, copy, distribute, create derivative works of, publicly perform, publicly display, digitally perform, practice the methods of, make, have made, import, export, offer for sale and sell such Assigned Intangibles for the entire duration of such rights(ii) such license rights that Company can convey or (iii) any assignable covenant not to sue. If Assignors have any such rights that cannot be assigned or licensed to Company in accordance with this Assignment, then Assignors waive the enforcement of such rights and both Parties agree that there is no obligation to assign such rights.

Assignors shall cooperate and take all steps, reasonably requested by Company to perfect, confirm, and protect Company's rights (including without limitation, Intellectual Property Rights), title, and interest in and to the Assigned Intangibles including without limitation, executing and delivering all documents, filing registration and assignment documents, and giving testimony.
