ASSIGNOR further agrees that ASSIGNOR will (a) cooperate with ASSIGNEE in the prosecution of U.S. Patent applications and foreign counterparts on the invention and any improvements thereon, (b) execute, verify, acknowledge and deliver all such further papers, including applications and instruments of transfer, and (c) perform such other acts as ASSIGNEE lawfully may request to obtain or maintain any Letters Patent and Registrations for the invention and improvements in any and all countries, and to vest title thereto in ASSIGNEE, or ASSIGNEE's successors and assigns.
