## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the “**Release**”) is made as of the 4<sup>th</sup> day of November, 2020, between CUBEX LLC, an Arizona limited liability company (“**Assignee**”), and SILICON VALLEY BANK, a California corporation (the “**Assignor**”).

WHEREAS, in connection with certain loan documents, Assignee and Assignor entered into that certain Loan and Security Agreement dated as of September 9, 2015 (as amended, supplemented, or otherwise modified from time to time, the “**Loan Agreement**”) and the Intellectual Property Security Agreement dated as of September 9, 2015 (as amended, supplemented, or otherwise modified from time to time, the “**IP Agreement**”) for the purpose of securing certain obligations of Assignee to Assignor;

WHEREAS, pursuant to the Loan Agreement and IP Agreement, Assignee granted Assignor, for the benefit of Assignor, a security interest in all of Assignee’s Intellectual Property (as defined in the Loan Agreement), including the Patents identified on Exhibit A attached hereto and the Trademarks identified on Exhibit B attached hereto (the “**Released Intellectual Property**”), and pledged and mortgaged (but did not transfer title to) such Intellectual Property to Assignor; and

WHEREAS, Assignee has requested that Assignor, and Assignor has agreed to, release its security interest in the Released Intellectual Property.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Agreements:

Assignor hereby terminates and releases its security interest in the Released Intellectual Property and Assignor hereby assigns and transfers to Assignee, without any representation, warranty, or recourse whatsoever, Assignor’s entire right, title, and interest in and to the Released Intellectual Property, effective as of the date set forth above.

The Assignor understands and agrees that this Release may be recorded by or for the Assignee with the United States Patent & Trademark Office or Copyright Office, as applicable.

Assignor hereby agrees to execute such further instruments and documents and perform such further acts as Assignee may deem necessary to secure to Assignee the rights herein conveyed.
