CPPIB RELEASE OF SECURITY INTEREST IN U.S. PATENTS (CIPMI)

This CPPIB RELEASE OF SECURITY INTEREST IN U.S. PATENTS (CIPMI) (this “Release”), dated as of October 28, 2020, is made by CPPIB Credit Investments Inc. (“CPPIB”) in favor of Conversant Intellectual Property Management Inc. (“CIPMI”). Capitalized terms used and not defined herein have the meanings given to such terms (whether directly or by reference to another agreement or document) in the U.S. IP Security Agreement (as defined below).

WHEREAS, CIPMI and CPPIB are parties to that certain Amended and Restated U.S. Intellectual Property Security Agreement (For Non-U.S. Grantors), dated as of July 31, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “U.S. IP Security Agreement”), to that certain U.S. Patent Security Agreement (For Non-U.S. Grantors), dated as of June 11, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “2014 U.S. Patent Security Agreement”), and to that certain Amended and Restated U.S. Patent Security Agreement (For Non-U.S. Grantors), dated as of July 31, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “2018 U.S. Patent Security Agreement”), pursuant to which CIPMI granted to CPPIB a security interest in all of such grantor’s right, title and interest in, to and under all Patents of such grantor listed on Schedule A attached hereto (“CIPMI Patent Collateral”);

WHEREAS, the 2014 U.S. Patent Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on September 9, 2014, at Reel/Frame 033706/0367, and the 2018 U.S. Patent Security Agreement was recorded with the USPTO on August 22, 2018, at Reel/Frame 046900/0136;

WHEREAS, pursuant to that certain Lien Release and Payoff Letter, dated as of October 15, 2020, among CIPMI and CPPIB, CPPIB terminated and released its security interest in certain assets of CIPMI, including the CIPMI Patent Collateral; and

WHEREAS, CPPIB has agreed to execute and deliver this Release to evidence the release of its security interest in the CIPMI Patent Collateral.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CPPIB hereby terminates and releases the entirety of its security interest in the CIPMI Patent Collateral, and hereby re-assigns, re-transfers and re-conveys to CIPMI any and all right, title and interest CPPIB may have in, to or under the CIPMI Patent Collateral.

CPPIB hereby authorizes CIPMI to record this Release with the USPTO.

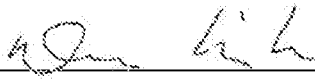
