For the above consideration, Assignor agrees promptly upon request of Assignee to execute and deliver without further compensation any additional papers and make all rightful oaths, and all other acts which may be necessary to secure, obtain or enforce the Patents and all associated rights in the United States including any additional documents needed to record and fully effect the transfer of patent rights made herein in the United States.
4. Governing Law. This Patent Assignment shall be exclusively governed by and construed in accordance with the laws of the State of Ohio without regard to principles of conflicts of law.





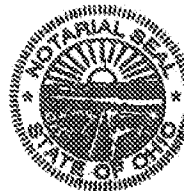
