**SECURITY AGREEMENT / NOTICE OF SECURITY INTEREST
(U. S. PATENTS – Refined Technologies, Inc.)**

THIS SECURITY AGREEMENT/NOTICE OF SECURITY INTEREST (PATENTS) (this "Agreement") entered into as of October 22, 2020, is made by Refined Technologies, Inc., a Delaware corporation (the "Grantor") in favor of BANCFIRST, as Lender ("Lender").

WHEREAS, Grantor holds all right, title and interest in the letter patents, design patents and utility patents listed on the annexed Exhibit 1, which patents are issued or applied for in the United States Patent and Trademark Office, as more fully set forth on Exhibit 1 (the "Patents"); and

WHEREAS, pursuant to the First Amendment to Credit Agreement dated as of October 22, 2020 ("First Amendment"), between and among Grantor and certain affiliates, as borrowers (collectively, the "Borrowers"), and the Lender, the Lender has agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein; and

WHEREAS, the Borrowers have entered into a Supplemental Security Agreement dated as of even date with the First Amendment (the "Security Agreement"), in favor of the Lender; and

WHEREAS, pursuant to the Security Agreement, Grantor has granted to the Lender a continuing security interest in all right, title and interest of Grantor in, to and under the Patents and the applications and reissues, continuations, extensions, and reexaminations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Patent Collateral"), to secure the payment, performance and observance of the Obligations (as described in the Security Agreement); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants to the Lender, a continuing security interest in the Patent Collateral to secure the prompt payment, performance and observance of the Obligations.

In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

Grantor does hereby further acknowledge and affirm that the rights and remedies of the Lender with respect to the Patent Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

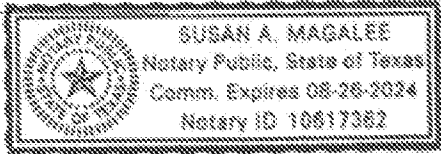
