ASSIGNMENT

WHEREAS, Cavium International, a corporation organized under the laws of Cayman Islands, and with offices at c/o Ocorian Trust (Cayman) Limited, P.O. FURTHER, nothing contained herein shall be deemed to alter or amend the terms and provisions of the Purchase Agreement and in the event of any conflict between the terms and provisions of this Assignment and the Purchase Agreement, the terms and provisions of the Purchase Agreement shall be deemed to govern and be controlling in all circumstances. This Assignment is executed pursuant to the Purchase Agreement and is entitled to the benefits and subject to the provisions thereof and shall bind and inure to the benefit of the parties thereto and their respective successors and assigns.

FURTHER, Assignor hereby covenants and agrees to execute and deliver, at the request of Assignee, such further instruments of transfer and assignment and to take any other action as such Assignee may reasonably request to more effectively consummate the assignments contemplated by this Assignment. Specifically, Assignor agrees to, at Assignee's expense, execute, acknowledge and deliver such further documents, instruments, conveyances and assurances and take such further actions as may be reasonably required to register in the name of Assignee the assignment of any of the Patents in **Group A** in any appropriate governmental agency or registrar.
