RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “**Release**”) is made as of November 9, 2020, by ARES CAPITAL CORPORATION., as collateral agent for the Lenders and the other Secured Parties (in such capacity, together with its successors and permitted assigns, the “**Collateral Agent**”), in favor of ZAREBA SYSTEMS, INC. (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are party to (i) that certain Guarantee and Collateral Agreement dated as of June 21, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Patent Security Agreement, dated as of June 21, 2017 (the “**Patent Security Agreement**”), whereby the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest in, to and under the following (collectively, the “**Patent Collateral**”):

- (a) all of its Patents, including, without limitation, those referred to on Schedule I hereto;
- (b) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing;
- (c) all rights to sue or otherwise recover at law or in equity for any past, present or future infringement or other violation or impairment thereof; and
- (d) all income, royalties, proceeds, damages and liabilities at any time due or payable or asserted under and with respect to any of the foregoing.

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 24, 2017 at Reel/Frame 043083/0684; and


WHEREAS, the Grantor has requested that the Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Patent Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby releases and terminates its security interest in the Patent Collateral, and re-assigns and re-conveys to the Grantor any and all right, title or interest the Collateral Agent may have in, to or under the Patent Collateral.
