Assignor further agrees that Assignor will, without charge to Assignee, but at Assignee's expense, (a) cooperate with Assignee in the prosecution of the foreign counterparts of the Invention, (b) execute, verify, acknowledge and deliver or possibly deliver all such further papers, including instruments of transfer and (c) perform other such acts as Assignee lawfully may request to obtain or maintain Letters Patent and Registrations for the Invention in any and all countries, and to vest title thereto in Assignee, or Assignee's successors and assigns.


