ASSIGNMENT OF INVENTION

WHEREAS, John Baillet (hereinafter "ASSIGNOR") located at 7019 Breen Dr., Houston, TX 77086 has invented certain new and useful improvements in: US Patent Application No. 17/007721 entitled "Improved Face Shield and Method of Use", filed on August 31, 2020 ("Invention").

WHEREAS, Amdrecor (hereinafter referred to as "ASSIGNEE"), having a principal office and place of business at 7019 Breen Dr., Houston, TX 77086 desires to acquire from ASSIGNOR the entire right, title and interest in, and to, said Invention and in, and to, any Letters Patent that have been or that may be filed or granted thereof in the United States and its territorial possession, and in any and all countries foreign to the United States of America;

NOW, THEREFORE, for valuable consideration, the receipt whereof is hereby acknowledged, ASSIGNOR by these present does sell, assign and transfer unto said ASSIGNEE, all of my individual and group rights to the said Invention in the United States and its territorial possessions and all countries foreign to the United States of America, and my entire right, title and interest in and to any and all Letters Patent, and or patent applications, which have been and which may be granted therefore in the United States and its territorial possessions and in and to any and all divisions, derivatives, reissues, continuations, substitutions and renewals thereof, and to any and all Letters Patent which may be granted therefore in all countries foreign to the United States for payment to the ASSIGNOR of the amount of \$315,659.76 which is the present value on a 5% royalty of a \$1,000,000.00 license on the Invention over a 17 year period.

ASSIGNOR also assigns all rights to pursue any and all intellectual property protections of the Invention, including filing and prosecuting, patent applications, trademark applications and copyright applications. Upon assignment of these rights, ASSIGNOR retains no rights at all in the Invention.

Further, ASSIGNOR agrees that they will communicate to said ASSIGNEE or its representatives any facts known to us respecting said Invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything

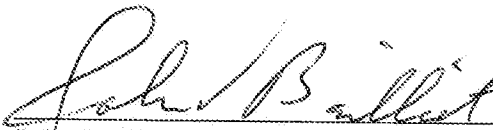
possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said Inventions in the United States and its territorial possessions, and in all countries foreign to the United States.

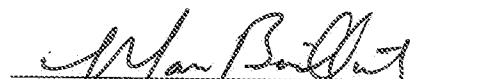
