## ASSIGNMENT

Assignor further authorizes and requests any official, whose duty it is to issue patents, to issue any patent on the inventions and improvements resulting therefrom to Assignee, or its successors or assigns, and agrees that on request and without further consideration, Assignor will communicate to Assignee or its representatives or nominees any facts known to Assignor respecting the inventions, know-how, trade secrets, and improvements and testify in any legal proceeding, make all rightful oaths, sign all lawful papers and execute all instruments or documents required or requested for the making and prosecution of any applications of any type for patent, utility model, or other similar rights in all countries including, but not limited to, any provisional, non-provisional, continuation, continuation-in-part, divisional, renewal or substitute thereof, for any derivation proceedings relating thereto, and, as to any patents that issue from such applications, for any supplemental examination, derivation proceeding, opposition, post grant review, reissue, re-examination, inter partes review, or extension thereof, and generally do everything possible to aid Assignee, its successors, assigns, and nominees to obtain and enforce proper intellectual property protection for the invention, know-how, trade secrets, and improvements in all countries.
