**FOURTH:** The merger is to become effective upon filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

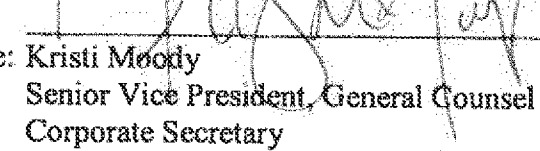
