**TERMINATION AND RELEASE OF SECURITY
INTEREST IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of October 30, 2020 (“Release”), is made by **Wells Fargo Capital Finance, LLC**, in its capacity as administrative agent for the Lender Group and the Bank Product Providers (“Administrative Agent”), a Delaware limited liability company, in favor of **The Dixie Group, Inc.**, a Tennessee corporation (“Dixie”), **Candlewick Yarns, LLC**, an Alabama limited liability company (“Candlewick”), **Fabrica International, Inc.**, a California corporation (“Fabrica”), **Masland Carpets, LLC**, a Georgia limited liability company (“Masland”), and **C-Knit Apparel, Inc.**, a Tennessee corporation (“C-Knit”; together with Dixie, Candlewick, Fabrica, and Masland, each a “Grantor” and, collectively, the “Grantors”).

WHEREAS, pursuant to that certain Patent Security Agreement dated as of September 13, 2011, among the Grantors and Administrative Agent (the “Security Agreement”), Grantors granted to the Administrative Agent, for the benefit of the Lender Group and the Bank Product Providers, a continuing security interest in all right, title and interest of Grantors in and to all Patents and Patent Intellectual Property Licenses to which each Grantor is a party, including the patents identified on the attached Schedule A; and

WHEREAS, the security interest identified herein was recorded with the United States Patent and Trademark Office (“USPTO”) on March 27, 2014, at Reel 032538 Frame 0978.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lender Group and the Bank Product Providers, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Lender Group and the Bank Product Providers, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:


- (a) terminates, cancels, discharges and releases the continuing security interest in, Grantors’ right, title, and interest in and to the patents identified on Schedule A attached hereto, granted pursuant to the Security Agreement; and
- (b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Georgia.
