## DEED OF ASSIGNMENT OF INTELLECTUAL PROPERTY

### PARTIES

- 1 **VICTORIA UNIVERSITY OF WELLINGTON** a New Zealand University established pursuant to the Victoria University of Wellington Act 1961, of Kelburn Parade, Kelburn, Wellington, New Zealand (the **Assignor**)
- 2 **VICTORIA LINK LIMITED**, a New Zealand company, of RB905, Rankine Brown Building, Kelburn Parade, Kelburn, Wellington, New Zealand (the **Assignee**)

### BACKGROUND

### COVENANTS

- 1 In this Deed:

**Patent Rights** means all patent rights in and to the Invention and any improvements, developments, modifications or enhancements of the Invention as may exist or come into existence anywhere in the world, including (without limit):

- (a) the right to apply for and obtain patents or other similar forms of protection in respect of the Invention in any country;
- (b) the right to claim priority under any international convention or agreement for any application(s) referred to in paragraph (a) above;
- (c) all rights conferred by any such patent(s) or similar forms of protection when granted;
- (d) [the patents set out in Part B of the Schedule to this Deed;
- (e) the patent application(s) set out in Part B of the Schedule to this Deed (**Patent Application(s)**) together with any patent that may be granted pursuant to the Patent


Application(s) and any future patent(s) and patent applications that are based on or derive priority from or have equivalent claims to the Patent Applications in any country in the world.

- 2 The Assignor assigns to the Assignee all of its estate, rights, title, interest, benefit, property, claim and demand in and to the Assigned IP.
- 3 The assignment in clause 2 includes, without limit, the right to sue or bring proceedings against any third party for infringement of the Assigned IP (whether such infringement occurs before, on or after the date of this Deed) and the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on or after the date of this Deed.
- 4 The Assignor agrees to do all things and execute all documents as the Assignee considers necessary or desirable to:
  - (a) give effect to the assignment in clause 2, including (without limit) perfecting any part of that assignment; and
  - (b) assist the Assignee in the protection and enforcement of the Assigned IP.
- 5 A copy of this Deed may be filed at the Intellectual Property Office of New Zealand or the equivalent office in an overseas jurisdiction (where applicable) by the Assignee as evidence of the assignment of the Assigned IP from the Assignor to the Assignee.
- 6 This Deed shall be governed by New Zealand law and the courts of New Zealand have non-exclusive jurisdiction in relation to all disputes arising out of or in connection with this Deed.
