2. Assignor represents and warrants that it has the right to make this Assignment, that the undersigned has the authority to bind Assignor and act on Assignor's behalf, and that there are no outstanding prior assignments except to Assignee.
3. The terms and covenants of this Assignment shall inure to the benefit of the Assignee, its successors and assigns and other legal representatives, and shall be binding upon the Assignor, its successors, legal representatives and assigns.


