For the sake of clarity, *Assignor* agrees that the entire right, title, and interest, that is assigned, transferred, and conveyed herein shall include the entire right, title, and interest, without limitation, worldwide, in and to any subsequently filed non-provisional, divisional, continuation, continuation-in-part, or reissue patent application filed in the United States, foreign patent application filed directly or indirectly in a foreign patent office, foreign patent application filed in a foreign patent office under the Paris Convention, Patent Cooperation Treaty (hereinafter “PCT”) international application, PCT national phase entry patent application, and any other patent application and any patent or patents that issue therefrom that claim, directly or indirectly, priority to, or claim the benefit of the filing date of, the *Patent Application*.

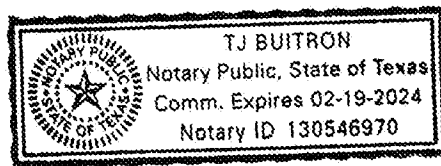

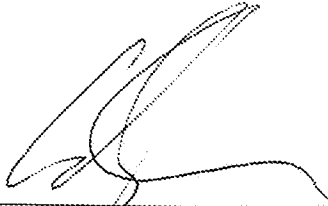

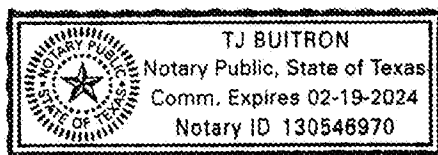
