RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of November 19, 2020, by WILMINGTON SAVINGS FUND SOCIETY, FSB, in its capacity as Collateral Agent for the Secured Parties under (and as defined in) the Guarantee and Collateral Agreement referred to below (the "Collateral Agent") for the benefit of IQOR HOLDINGS INC. ("Holdings"), a Delaware corporation, IQOR US INC. ("Borrower"), a Delaware corporation and each Subsidiary of Holdings (other than Borrower) listed thereon Schedule I of the Guarantee and Collateral Agreement (collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Guarantee and Collateral Agreement (as defined below) or the Intellectual Property Security Agreement (as defined below) as applicable.

W I T N E S S E T H:

WHEREAS, the Grantors and the Collateral Agent are parties to that certain (i) Super-Priority Debtor-In-Possession Guarantee and Collateral Agreement, dated as of September 15, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"); and (ii) Super-Priority Debtor-In-Possession Intellectual Property Security Agreement, dated as of September 15, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), pursuant to which the Grantors have granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantors in, to and under the IP Collateral (as defined in the IP Security Agreement), including the patents, trademarks, copyrights, and exclusive copyright licenses set forth on Schedules A, B, C, and D hereto; and

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on September 15, 2020 at Reel 7053 and Frame 0069 for trademarks and recorded on September 15, 2020 at Reel 053785 and Frame 0501 for patents; and

WHEREAS, Grantors have requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Intellectual Property Collateral, including, without limitation, the patents set forth on Schedule A and the trademarks set forth on Schedule B hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Guarantee and Collateral Agreement or IP Security Agreement to the Intellectual Property Collateral, including, without limitation, the patents (including the patents and patent applications) set forth on Schedule A hereto, and the trademarks (including the trademark registrations and trademark applications) set forth on Schedule B hereto, the goodwill of the business symbolized by the trademarks and the

applications and registrations thereof, and all proceeds thereof, and any right, title or interest of the Collateral Agent in such Intellectual Property Collateral shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Intellectual Property Collateral to the Grantors.

2. The Collateral Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the IP Security Agreement.



4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
