RELEASE OF SECURITY INTERESTS IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”), dated as of December 1, 2020, is executed by KAYNE SENIOR CREDIT II GP, LLC, in its capacity as agent (in such capacity, “Agent”), in favor of NOVIPAX LLC, a Delaware limited liability company (“Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (as defined below).

RECITALS

A. WHEREAS, Grantor has, pursuant to that certain Patent Security Agreement dated March 31, 2016, recorded in the United States Patent and Trademark Office (the “USPTO”) on March 31, 2016 at Reel 38163, Frame 0238 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Security Agreement”), granted to Agent a security interest in and to all of Grantor’s right, title and interest in, to and under the Patent Collateral, including without limitation those patents listed on Exhibit A attached hereto (the patents listed on Exhibit A are the “Released Collateral”); and

B. WHEREAS, Agent wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby terminates, discharges and releases, without recourse its security interest in and to the Released Collateral and terminates the Security Agreement as to the Released Collateral. Agent represents and warrants that: (i) it has the full power and authority to execute this Release and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.


