## ASSIGNMENT

THIS AGREEMENT is made the 2<sup>nd</sup> day of July 2018

BETWEEN

GOH Chin Heng c/o Temasek Life Sciences Laboratory of 1 Research Link, National University of Singapore, Singapore 117604;

hereinafter referred as "the Assignor" of the one part,

AND

Temasek Life Sciences Laboratory of 1 Research Link, National University of Singapore, Singapore 117604;

hereinafter referred to as "the Assignee" of the other part.

WHEREAS:

- A) The Assignors are the inventors of the invention described in SG patent application no. 10201804724U entitled AQUATIC FARMING IN INTERMODAL CONTAINERS filed 04 June 2018 (hereinafter referred to as "the Intellectual Property").
- B) The parties hereto have agreed that the rights in the invention should be transferred by the Assignors to the Assignee on the terms hereinafter defined and for the consideration hereinafter set forth in all countries.

NOW THIS ASSIGNMENT WITNESSETH:

1. In consideration of the sum of SGDS1 now paid by the Assignee to the Assignors (the receipt whereof is hereby acknowledged), the Assignors hereby assign absolutely to the Assignee free from encumbrances:
  - (A) ALL of their right title and interest in and to the Intellectual Property and, as of the effective date hereinafter defined, all rights and powers arising or accrued therefrom to the intent that the Intellectual Property shall be in the name of and vest in the Assignee;
  - (B) the right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of the Intellectual Property, including the right to claim priority therefrom to the intent that the grant of any patent(s) or similar protection shall be in the name of and vest in the Assignees.
2. This Assignment is to have an effective date of 3<sup>rd</sup> May 2018.
3. The Assignors further covenant that at the request and cost of the Assignee, the Assignors shall:


- (A) assist the prosecution of the Intellectual Property to grant and shall execute all documents and do all acts as may be necessary or proper to obtain the acceptance and grant thereof; and
- (B) execute all such documents and do all such acts as may reasonably be necessary or proper to secure the vesting in the Assignees of all rights assigned hereunder.

4. Counterparts: this agreement may be signed in any number of counterparts (including facsimile and electronic copies). All counterparts, when taken together, will constitute one and the same agreement. The party may enter this agreement by signing any counterpart.

5. Jurisdiction: the formation, validity, construction and performance of this agreement will be governed by and construed in accordance with the laws of Singapore.




