PATENT ASSIGNMENT

This PATENT ASSIGNMENT (this "Assignment") is dated as of December 1, 2020, by and between Abbott Rapid Diagnostics International Unlimited Company, a company existing under the laws of Ireland and having a registered address of 70 Sir John Rogerson's Quay, Dublin 2, Ireland and a principal place of business at Office 32, Verdala Business Center Level 2, LM Complex, Brewery Street, Zone 3, Central Business District, Birkirkara, CBD 3040, Malta (hereafter called "Assignor") and Abbott Diagnostics Scarborough, Inc., a Delaware corporation having an address of 10 Southgate Road, Scarborough, Maine 04074 (hereafter called "Assignee"). Assignor and Assignee may be referred to herein collectively as the "Parties" and individually as a "Party".

WHEREAS, Assignor has agreed to assign and transfer to Assignee and Assignee has agreed to acquire and accept from Assignor, the patent applications and patents set forth on Schedule A attached hereto.

NOW, THEREFORE, intending to be legally bound and in consideration of the mutual provisions set forth in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor has assigned and/or by these presents does hereby assign, transfer, and convey unto Assignee all of Assignor's right, title, and interest in and to:

(a) The patents, patent applications, statutory invention registrations, utility models, utility model applications, petty patents, provisionals, non-provisionals, design patents and certificates of invention and patent disclosures, together with all reissues, continuations, continuations-in-part, divisions, revisions, extensions, restorations and reexaminations thereof specifically listed in Schedule A;

(b) all rights pertaining to any of the foregoing arising under international treaties and convention rights;

(c) the right and power to assert, defend and recover title to any of the foregoing;

(d) all rights to assert, defend and recover for any past, present and future infringement, misuse, misappropriation, impairment, unauthorized use or other violation of any of the foregoing; and

(e) all administrative rights arising from the foregoing, including the right to prosecute applications and oppose, interfere with or challenge the applications of others, the rights to obtain renewals, continuations, divisions, and extensions of legal protection pertaining to any of the foregoing.

2. Enjoyment. The foregoing rights shall be held and enjoyed by Assignee, for Assignee's use and benefit, and for Assignee's legal representatives and assigns, to the full end of the term, or terms for which same may be granted, as fully and entirely as the same would have been held by Assignor had this assignment and transfer not been made.
