The said entire right, title and interest shall vest irrevocably in said Assignee.

WE FURTHER AGREE upon request, without additional compensation but at no expense to ourselves, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the entire right, title and interest hereby transferred in said Assignee, its legal representatives, successors and assigns, or as the said company may direct.

WE HEREBY REQUEST the Commissioner of Patents and Trademarks of the United States and officials in Canada and all foreign countries to issue all patents or legal equivalents which may be issued for said invention to the said Assignee, its legal representatives, successors and assigns, as the sole owner of the entire right, title and interest in and to said patents and inventions covered thereby.




