PATENT ASSIGNMENT

This PATENT ASSIGNMENT, dated as of November 27, 2019 (this "<u>Assignment</u>"), is by and between Intel Corporation, a Delaware corporation, with an address at 2200 Mission College Boulevard, Santa Clara, CA 95014 (the "<u>Assignee</u>"), and Intel IP Corporation, a Delaware corporation, with an address at 2200 Mission College Boulevard, Santa Clara, CA 95014 (the "<u>Assignor</u>"). Each of the Assignee and the Assignor are referred to herein as a "Party."

RECITALS

WHEREAS, the patents and patent applications set forth on <u>Schedule 1</u> attached hereto (the "<u>Transferred Patents</u>") are registered in the name of Assignor;

WHEREAS, the Assignee and Apple Inc. are parties to that certain Master Asset Purchase Agreement, dated as of July 25, 2019 (as it may be amended from time to time) (the "Purchase Agreement"), pursuant to which the Assignee has agreed to assign, transfer and convey to Apple Inc. all of the Assignee's and certain of its affiliates' (including Assignor's) right, title, and interest in and to certain patents and patent applications (including the Transferred Patents); and

WHEREAS, in furtherance of such ultimate assignment to Apple Inc., the Assignor has agreed to assign, transfer and convey to the Assignee all of the Assignor's right, title, and interest in and to the Transferred Patents, and the Assignee has agreed to purchase the Transferred Patents.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and the mutual promises and conditions hereinafter set forth, and for other good and valuable consideration (including the payment by Assignee to Assignor of the sum of USD \$100.00), the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, do hereby agree as follows:

- 1. <u>Conveyance and Acceptance</u>. The Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee, and the Assignee hereby purchases, all of the Assignor's right, title and interest in and to the Transferred Patents, along with any and all rights to sue and recover for past, present and future infringement, misappropriation, misuse or violation with respect to the Transferred Patents, together with all rights under international treaties relating to the Transferred Patents. The foregoing rights include the right to claim priority to the Transferred Patents.
- 2. <u>Acknowledgement</u>. To the extent that <u>Schedule 1</u> hereto contains any typographical or administrative error, but it is clear which patent or patent application was intended to be included in the sale, assignment, transfer and conveyance under this Assignment, Assignor and Assignee each acknowledge and agree that the intended patent or patent application is hereby sold, assigned, transferred and conveyed, along with all other rights, privileges and claims enumerated above with respect to such intended patent or patent application.

- 3. Recordation. The Assignor hereby authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee and owner of the Transferred Patents and to deliver to the Assignee, and to the Assignee's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.
- 4. <u>Disclaimer of Representations and Warranties</u>. THE ASSIGNEE UNDERSTANDS AND AGREES THAT THE ASSIGNOR MAKES NO REPRESENTATIONS OR WARRANTIES IN ANY WAY PURSUANT TO OR IN CONNECTION WITH THIS ASSIGNMENT.
- 5. <u>Governing Law</u>. This Assignment, and all claims or causes of action based upon, arising out of, or related to this Assignment or the transactions contemplated hereby, shall be governed by and construed in accordance with the laws of the State of Delaware applicable to contracts executed and to be performed wholly within such State and without reference to the choice-of-law principles that would result in the application of the laws of a different jurisdiction.
- 6. <u>Counterparts</u>. This Assignment may be executed in multiple counterparts, and by any of the Parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same Assignment. Delivery of an executed counterpart of a signature page to this Assignment by .pdf, .tif, .gif or similar attachment to electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.


