

maintain or enforce patents for the Invention and improvements therein in any and all countries and to vest title thereto in Assignee.



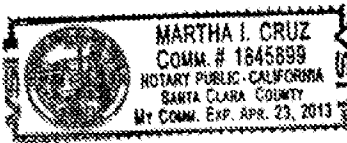
