(i) any and all extensions of and additions to said design patents or registrations of countries foreign to the United States of America.



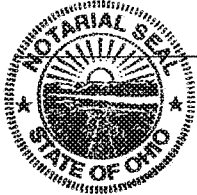


