**PATENT ASSIGNMENT AGREEMENT**

This **PATENT ASSIGNMENT AGREEMENT** (this “**Agreement**”) is entered into by and among **Beam Solutions, Inc.**, a Delaware company, located at 559 Clyde Ave #240, Mountain View, California 94043, USA, and **Jumio Corporation**, a Delaware company, located at 395 Page Mill Road, Ste 125, Palo Alto, CA 94306, USA. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Assignor, the Assignor does hereby sell, assign, transfer and convey to the Assignee all of the Assignor's right, title and interest in, to and under the patents and patent applications set forth on **Schedule A**, in and to the inventions claimed or claimable therein, in the United States and its territories and in foreign countries, as well as any reissue, renewal, division, continuation or continuation-in-part or any foreign counterpart thereof, or any other application that claims priority to the patents and patent applications set forth in **Schedule A**, including foreign patent priority rights, the right to file and prosecute International Applications under the Patent Cooperation Treaty, and the right to file and prosecute applications under the European Patent Convention, together with all past, present, or future claims arising out of any infringement thereof, and all rights to claim priority on the basis of such patent applications and/or patents in the United States or in any foreign country; and all such rights above to be held and enjoyed by the Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by the Assignor if this Agreement and sale had not been made.

The Assignor hereby binds itself, its successors, assigns or other legal representatives, properly to execute without further consideration, any and all applications, petitions, oaths and assignments or other papers and instruments that may be necessary in order to carry into full force and effect the sale, assignment, transfer and conveyance hereby made or intended to be made.
