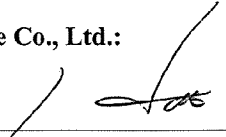

By virtue of an Exclusive Patent Sub-Sublicense Agreement dated 1 April 2016, 2TP granted a worldwide exclusive sub-sublicense of the Patents and the Applications to **Dualitas Ltd.** (f/k/a Dagri Holographics Ltd.) ("Dualitas") of 1a Garforth Place, Knowlhill, Milton Keynes MK5 8PG, UK, in all technical fields except automotive, defence and aerospace and a non-exclusive license of the Patents and Applications in the fields of automotive, defence and aerospace; and
5. By virtue of a Non-Exclusive Patent Sub-Subsublicense Agreement dated 9 March 2018, Dualitas granted to **Envisies Ltd.** a non-exclusive sublicense of the Patents and Applications in the field of automotive.

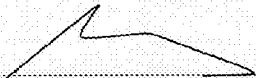

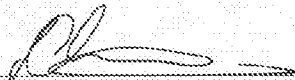
