ASSIGNMENT

Michael K. Holloway, residing at 15183 State Line Road, Willshire, Ohio 45898 and Mark R. Bryant, residing at 9555 E 300 S, LaOtto, Indiana 46763 (hereinafter referred to as Assignor) has co-invented certain new and useful improvements in a PATIENT SUPPORT APPARATUSES WITH DATA RETENTION MANAGEMENT for which a United States provisional patent application was filed in the U.S. Patent Office on December 20, 2019, and assigned application serial number 62/951,404.

Vehicle Control Solutions, Inc., a corporation of the State of Indiana, having a place of business at 71 E 400 S, Albion, Indiana 46701 (hereinafter referred to as Assignee), and having employed Assignor during the time of the invention embodiment in the above-mentioned patent application, desires to acquire all of Assignor's right, title, and interest in and to the invention and all patents that may be granted therefor anywhere in the world (hereinafter referred to as Acquired Rights) so that Assignee may subsequently transfer all of the Acquired Rights to Stryker Corporation.

For good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor sells, assigns, and transfers unto Assignee the entire right, title, and interest in and to (a) the invention in the United States and in all foreign countries, (b) the application, (c) all provisional applications from which the application claims priority, (d) all nonprovisionals, divisions, continuations, continuations-in-part, reissues, reexaminations, substitutions, renewals, and extensions claiming priority directly or indirectly from the application including the right to claim for any such application the benefits of the International Convention; and (e) all patents that may be granted on any of the foregoing in the United States and in all foreign countries.

Assignor authorizes and requests the patent office officials in the United States and in all foreign countries to issue all of the patents, when granted, to Stryker Corporation as the owner of the entire right, title, and interest in and to the same.

Assignor agrees to communicate to Stryker Corporation, or its representatives, all facts known to Assignor respecting the invention; to testify in all legal proceedings; to sign all documents; to execute all nonprovisional, divisional, continuation, continuation-in-part, reissue, reexamination, substitution, renewal, and extension applications; to execute all necessary assignment documents to cause all of the patents to be issued to Stryker Corporation, to make all rightful oaths, and generally to do everything possible to aid Stryker Corporation, its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in all foreign countries.
