which application is referred to as "the patent application."



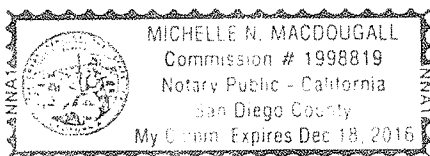


